Proclamation No. 241/2021, A Proclamation Amended to Redefine the Organization, Duty, Conduct of the Members and Meeting Procedures of the 'Caffee' of the Regional State of Oromia, No.201/2017

Caffeen Mootummaa Naannoo Oromiyaa aangoo fi hojii Heeraa fi ummataan itti kenname gahumsaan bahachuu kan isa dandeessisu gurmaa'ina isaa qaamolee fi manneen hojii mootummaa hordofuu fi to'atu waliin walsimsiisuuf, akkasumas gurmaa'inaa fi hojimaata Koreewwan Dhaabbii irra deebiidhaan fooyyeessuun saffinaa fi bu'a qabeessummaa raawwii hojii Caffeeitiif barbaachisaa ta'ee waan argameef;

WHEREAS, it has become necessary to 'Caffee' of the Regional State of Oromia, to discharge its power and duty given to it by the Constitution and the people efficiently, it is necessary to have an organizational structure that is compatible with other government organs that it oversees; as well as reorganizing the standing committees organization and procedure to ensure efficient and effective performance for the duty of the Caffee;

Akkaataa Heera Mootummaa Naannoo Oromiyaa Fooyya'ee Bahe, Labsii Lakk. 46/1994 Keewwata 49 Keewwata Xiqqaa 3 (a) fi Keewwata 52 Keewwata Xiqqaa 3tiin kan kanatti aanu labsameera.

NOW, THEREFORE, in accordance with Article 49 sub article 3 (a) and Article 52 sub article 3 of the Revised Constitution of the Regional State of Oromia, Proclamation No.46/1994. It is here by proclaimed as follows.

1. Short Title

This proclamation may be cited as “Proclamation No. 241/2021 A Proclamation to Amend the Organization, Duty, Conduct of Members and Meeting Procedures of the ‘Caffee’ of the Regional State of Oromia”

2. Amendment

Proclamation No. 201/2017 of the Organization, Duty, Conduct of the Members and Meeting Procedures of the ‘Caffee’ of the Regional State of Oromia, has been amended as follows:

- 1) Following Article 4 sub article 4(g), Sub article 4(h) new article is added:
- 4(h)’The Members of ‘Caffee’ shall have organization at constituency level.
- 2) Article 16 sub article 3 is repealed and replaced as follows:
- 16(3)’ After the draft budget reached the Secretariat of Caffee, the Head of the Finance Bureau shall make a statement to the Coordinating Committee on the date and time to be assigned by the Speaker; and general discussion will be held on the draft.
- 3) Article 27 sub article 3 is repealed and replaced as follows:
- 27(3)’ Notwithstanding the provisions of sub-article 2 of this Article, the Standing Committee of Administration, Law and Human Resource Development shall be obliged to examine any draft law.

 44(1)' The 'Caffee' shall have the following Standing committees:
 (a) Administrative, Legal and Human Development Affairs Standing Committee;
 (b) Rural Development Affairs Standing Committee;
 (c) Urban Development Affairs Standing Committee;
 (d) Public Budget and Asset Controlling Affairs Standing Committee;
 (e) Women and Social Affairs Standing Committee.
 5) Article 44 sub article 3 is repealed and replaced by the following:
 44(3)' Each Standing Committee of the 'Caffee' including the Chairperson and the Deputy Chairperson, presented by the Speaker and nominated by the 'Caffee' shall have 5 or 7 Members. Number of the Members shall be depends upon their duties and numbers of the sectors they follow up and control.
 6) Article 44 sub article 4 is repealed and replaced as follows.
 44(4)' Each Standing Committee of the 'Caffee' including the Chairperson, if it is necessary it is possible to make 1 to 2 Deputy Standing Committees to work permanently in office. Its implementation shall be determined by the directive to be issued by the 'Caffee' Affairs Advisory Committee.
 7) Article 44 sub article 9 is repealed and replaced as follows:
 44(9)' Each Standing Committee will be supported by qualified and competent professionals.

- 50 (1)' The main objectives of the Administrative, Legal and Human Development Affairs Standing Committee shall be ensuring that the regional administrative government and justice Sector are organized and implementing according to the Constitution, Policies, Strategies, Programs, Laws and Plan; and as also ensuring that the policies, strategies, laws, of organization and duty, reforms and Developmental Perspectives in Leadership and Public Service increase to prevail good governance and it ensures that the people have confidence in the government.
- 10) Following Article 50 sub article 2 (i), new Articles are added as follows:
 - (j) Making sure that the performance of execution capacity in the region.
 - (k) To ensure rapid development, good governance, to develop a democratic culture in the community; ensuring efficient, quality, integrity and determination in human power and work with in the short term and large-scale production;
 - (l) Making sure that the policies, strategies, programs, Laws and capacity building plans are implemented effectively.
